INTRODUCTION

Chapter 13 of the Acts of 1987 requires the Comptroller to collect and compile statistical information from Maryland income tax returns, including component items of adjusted gross income, itemized deductions, and addition and subtraction modifications. The information is compiled annually for the State, each county and Baltimore City.

Since 1967, the comptroller has published aggregate information on income, deductions, exemptions, modifications and tax liabilities for the state and its component subdivisions in a Summary Report. However, the detailed information required by Chapter 13 is not collected by the State. This data is contained on federal tax returns filed by Maryland taxpayers and is compiled by the Internal Revenue Service (IRS).

METHODOLOGY

In a departure from versions of the Statistics of Income report for tax years before tax year 2000, parts of this report have been produced without using data sampling. Figures that appear in this report generally are the actual figures from returns filed with the Maryland and federal income tax returns Comptroller. The federal and State files were matched, but many Maryland returns had no corresponding federal return. This was largely because the federal information included only federal returns filed using a Maryland address. As one would expect, most nonresident returns and the returns of taxpayers who moved out of the State during the tax year were not included in the federal file. Other information is not captured by the imaging system used to process tax returns or was unavailable due to timing and/or other factors; therefore, using actual figures was not possible. Whenever detailed addition and subtraction information was missing, a sample of current-year electronic returns was used to impute this information, controlling for certain differences between these and imaged returns.

Starting with the tax year 2000 report, the data is stratified into twelve income groups based on Maryland Adjusted Gross Income (MD AGI). In prior reports taxpayers with MD AGI over \$100,000 were divided into two groups: over and under \$200,000. The under \$200,000 stratum has been broken into two segments, with the dividing line at \$150,000. As the median household income in the State is now over \$50,000, having as many strata above that line as below it seemed appropriate.

ERROR RESOLUTION AND EDITING

Because sampling was not used for a large portion of the data presented in this version of the report, the number of data checks necessary was reduced. Figures generated were compared with the Income Tax Summary Report and prior Statistics of Income reports. In addition, the figures were reviewed to ensure they accurately reflect what we knew about changes in the tax code and economic conditions.

COMPARABILITY WITH PRIOR REPORTS

Starting with the tax year 2000 report, changes in federal and state law and improvements in the techniques used in creating the database will affect comparisons of the databases from year to year. The expansion in the number of income classifiers as well as an increase in the number of items presented from the return detail will provide additional data for this report and reports for later tax years. Overall this change should result in better information.

Senate Bill 1302 from the 2012 First Special Session enacted a number of substantial changes to the individual income tax, affecting the State's tax brackets and exemption amounts. In addition, unique economic conditions resulted in variations in many of the income tax categories presented in this report.

Major revisions were made to the State's tax rates and brackets. The top rate increases from 5.5% to 5.75%, and additional brackets and rates are added for all filing types. For **single filing types**, net taxable income (NTI) between \$100,000 and \$125,000 is taxed at 5%, NTI between \$125,000 and \$150,000 is taxed at 5.25%, NTI between \$150,000 and \$250,000 is taxed at 5.5%, and NTI above \$250,000 is taxed at 5.75%. For **joint filing types**, NTI between \$150,000 and \$175,000 is taxed at 5%, NTI between \$175,000 and \$225,000 is taxed at 5.25%, NTI between \$225,000 and \$300,000 is taxed at 5.5%, and NTI above \$300,000 is taxed at 5.75%.

For all filing types, with the exception of dependents, the personal exemption amount is changed to a maximum of \$3,200, phased down to a minimum of \$0 based on federal adjusted gross income (FAGI). Individuals filing as dependents (individuals

claimed as dependents on another taxpayer’s return) are still are not permitted to claim a personal exemption. The table below details the calculation of an individual’s exemption amount beginning in tax year 2012.

The maximum Maryland standard deduction was increased in tax year 2018 to \$2,250 for Single filers, Married Filing Separate filers and Dependent tax filers. Head of Household filers, Married Joint filers, and Qualifying Widow(ers) had their maximum standard deduction increased to \$4,500. This change was nearly twice the prior law’s standard deduction and, in concert with the Federal tax law changes noted below, had the effect of reducing the number of lower income tax filers that were required to file a tax return. As a result, the return counts and amounts presented in the lower income distributions in this report will generally be less than in previous year’s reports.

Maryland tax filers were also impacted by the passage of the Tax Cuts and Jobs Act of 2017 (TCJA, P.L. 115-97). The TCJA was the largest tax overhaul since 1986 and many of the changes impacted Maryland filers in a significant fashion. The most notable tax change was the increase to the Federal Standard Deduction. This single tax change altered the filing pattern of many Maryland filers and caused filers that used to claim itemized deductions to claim the increased standard deduction. This meant that Maryland filers that claimed the standard deduction at the Federal level would also have to claim the standard deduction on their Maryland tax

return as well. The increased standard deduction also eliminated the need for many lower income tax filers to file a Federal tax return. A consequence of the increased standard deduction was the reduction in the return counts and amounts found in the lower income distributions as compared to prior year's reports. Note that the increased standard deduction resulted in changes to many categories found in this report – such as, but not limited to, income amounts, deduction amounts, income modifications, tax credits, and tax liability. The TCJA also eliminated the personal exemption deductions at the Federal level as well as increased the amounts and income thresholds for claiming child tax credits. The last notable tax change in TCJA was the limitation on the amount of State taxes paid that could be claimed by individual tax filers (but not business filers) as an itemized deduction. This impacted higher income Maryland tax filers and without the full value of the taxes paid these filers may have chosen to claim the standard deduction. The implementation of the TCJA required the development of new tax forms and schedules, affected large numbers of taxpayers, consumed significant amounts of Internal Revenue Service resources, and influenced significant amounts of dollars. All of these factors had varying degrees of impacts on the results presented in this report but may not have been specifically noted here.

An asterisk (*) indicates that the data has been combined with one or more lower income classes.

For the county tables, particularly for smaller counties, the upper income classes were consolidated for the entire table if there were disclosure issues or no returns for the entire income class.
